## **Academic scope of conference**

The ideal of citizenship and its role in building (political) communities and so democracy more broadly have perhaps never been under as much pressure as today. This is especially so against the backdrop of bespoke processes of community (dis)integration at local, national, international and cross-cutting levels. One example is the increased call for independence by "non-selfgoverning territories" which possess and make claim for distinct social and political identities, such as Catalonia. Another is seemingly dis-United Kingdom that is not-quite withdrawn from the European Union. We can also draw on how the refugee crisis, for instance, underscores that the geography/space/identity nexus of traditional societal images and the political structures of states are not obsolete. If anything, this nexus appears as a rather permanent feature of practitioner and policy decisions today. While most of these examples have a distinct exclusionary tone, they are, inherently, about the forming of political communities. Equally importantly, they challenge conventional bottom-up and top-down processes of (political) participation and the assigning of (citizenship) rights to individuals. They are thus likely to serve as the latest 'reference points' for 'better' educating future



citizens about the desired ideals and practices of citizenship and democracy of tomorrow.

In order to <u>really</u> understand how these and similar community (dis)integration processes shape contemporary citizenship and democracy in EUrope and beyond, we invite empirical and theoretical contributions related, but not exclusive to the following topics:

- Ideals and practices of contemporary citizenship and democracy
- Processes of community dis/integration
- Themes and practices of inclusion, exclusion and the geography/space/identity nexus of contemporary democracy and citizenship
- The identity, rights and political participation of non/citizens

The conference will also include a keynote by Professor Elsbeth Guild on the 27th of June.

The speech will be followed by a networking event with academics and practitioners working on citizenship in/around UK/Europe broadly.

## **Event information**

The event is due to take place at the **University of Portsmouth** and will be funded by the <u>Centre of Excellence for the Study of Transnational</u>
<u>Europe</u> (CESTE2), especially Stream 2 on 'Societal Actors and (trans)national networking in a disintegrating Europe'.

The aim of the event is to offer a professional and critical setting for networking opportunity to academics, practitioners, and policy-makers. The event will be to bring together members of these groups in order to discuss and debate recent developments in national and European citizenship and democracy.

Paper proposals of maximum **300 words**, addressing, but not limited to, the above-mentioned issues are invited for submission.
