Letter from SG Convenors

Greetings to our colleagues as the autumn semester is underway! As we enter our second year as a Standing Group, we thank you for your contribution and encourage your continued interest and recruitment of scholars researching international education, research, and innovation policies.

In September we gathered in Oslo, Norway for the ECPR General Meeting. During our annual meeting, we discussed a variety of issues, including another new initiative: an open-source Syllabus Bank for our SG. The idea behind this Syllabus Bank, which will be hosted on the SG's website, is to provide our members and the wider public with access to how other scholars around the world design their courses in the areas of higher education, research and innovation policy. We believe the Syllabus Bank will be especially useful for scholars teaching for the first time, as well as those interested in updating their own course design, because it would offer an overview of both classic and contemporary scholarship across the knowledge domains. Beyond serving as a resource for instructors, the Syllabus Bank will also be useful for those seeking to understand how knowledge politics reconfigure contemporary public policy and society.

We are requesting syllabi from members to increase the number of courses listed (subject fields include, but are not limited to, higher education policy, education administration and governance, political economy of education, science and technology studies, research policies, and innovation policies). As with all initiatives, we welcome your input for enhancing the resources and services that the SG can provide to our members.

At Oslo we also presented the prize for the <u>winner of the Standing</u> <u>Group Award for Excellent Paper from an Emerging Scholar</u>. The second competition is underway and we encourage all Standing Group members to nominate their junior colleagues or themselves for this prize. Details are accessible on the <u>SG's website</u> and the deadline for submission is 15 December 2017.

As always please share your ideas with the convenors regarding research and teaching activities to support our work in the SG.

Call for Nomination: SG Excellent Paper from an Emerging Scholar Award

The ECPR Standing Group on the Politics of Higher Education, Research, and Innovation announces the call for an *Excellent Paper from an Emerging Scholar*. The winner of the 2017 Excellent Paper Award will be announced before the Standing Group meeting at the 2018 annual ECPR general conference in Hamburg, Germany and the award will be given at the meeting.

Eligibility and nomination process

A nominee is eligible if she/he fulfils all of the following criteria:

- 1. Is currently enrolled in a PhD Programme or has obtained PhD after August 2015;
- 2. Is the Sole or Lead Author in the paper to be presented;
- 3. Presented the paper at a conference or workshop between November 2016 and November 2017;
- 4. Submits the application via email by the **15th of December 2017**.
- 5. Has registered and extended his/her membership to the Standing Group as of 15th of December 2017.

The Judging Panel for the 2017 Excellent Paper from an Emerging Scholar include:

Dr Thomas Pfister – Head of the Energy Cultures Research Group, Zeppelin University, and the Associate Editor of *Innovation: The European Journal of Social Science Research*.

Professor Susan Robertson – Professor of Education, Faculty of Education, University of Cambridge, and Co-Editor of *Globalisation*, *Societies and Education*.

Professor Bjørn Stensaker – Professor, Department of Education, University of Oslo, and Research Professor at the Nordic Institute for Innovation, Research, and Education (NIFU).

SG Section at ECPR 2017, Oslo

This year's ECPR (European Consortium of Political Research) General Conference took place at the University of Oslo between September 6-9. The conference included hundreds of panels on a wide array of topics and representation from close to 2,000 academics from around the world. The ECPR <u>Standing Group on the Politics of Higher Education</u>, <u>Research and Innovation</u> organised a section with a total of six panels covering various themes related to knowledge policy governance.

Section Panels included:

- European Integration in the Knowledge Domain Taking Stock and Forward Outlook.
- Policy translation, adaptation and complexity in higher education, research and innovation
- Policy, Governance and Organisational Change in Higher Education.
- Research Executive Agencies Independent Organizations or the Extension of Research Policymakers?
- Unbundling knowledge production and knowledge dissemination aimed to conceptualise the 'unbundling' of knowledge policy
- The Quality and Effectiveness of Governance in Higher Education: Unpacking the Quality of Governance and Effects of Governance Changes in Higher Education Policies.

As has become tradition, the Standing Group also had its <u>annual meeting</u> focused on planning future activities, including ECPR 2018 which will take place in Hamburg. The meeting was also marked by the <u>Award for Excellent Paper from an Emerging Scholar</u> to Que Anh Dang for her paper "<u>The Bologna and ASEM Education Secretariats: Authority of Transnational Actor in Regional Higher Education Policy</u>". Standing Group members attended the keynote lecture by Johan P. Olsen "<u>Democratic Accountability and the Changing European Political Order"</u> and enjoyed the very generous hospitality of the <u>Nordic Institute for Studies in Innovation, Research and Education</u> NIFU, which hosted the traditional Standing Group dinner.

ECPR 2017 was another successful year for our Standing Group, gathering researchers from 20 different countries, currently based on three continents (Asia, Europe and North America). See you in the next ECPR General Conference in Hamburg in August 2018!
