Award of the 2019 Excellent Paper from an Emerging Scholar to Justyna Bandola-Gill

At the virtual ECPR SG meeting we also presented the winner of the Standing Group Award for Excellent Paper from an Emerging Scholar.



Justyna Bandola-Gill, Winner of the 2019 Excellent Paper Award Competition. Justyna is a Research Fellow in Social Policy at the School of Social and Political Science at the University of Edinburgh.

Our jury, comprised of Professor Luis Sanz-Melendez (Instituto de Políticas y Bienes Públicos, Madrid [Institute of Public Goods and Policies]), Professor Susan Robertson (University of Cambridge) and Professor Bjørn Stensaker (University of Oslo), has decided to award the Excellent Paper Award to Justyna Bandola-Gill for the paper "Knowledge exchange repertoires: Producing and translating evidence for policy". Below follows the jury's explanation:

"The manuscript focuses on researchers' perspectives on knowledge exchange and how they shape strategies and practices translating knowledge into policy. Although knowledge exchange is a challenging and tricky concept, Bandola-Gill manages to contextualize and operationalize the concept both theoretically and as an object of empirical analysis. The theoretical framework is well designed, based on a vast corpus of relevant literature, which fits very well with the intended objectives. The empirical basis is very strong and other key elements of the study – specifically methodology and findings – are clearly presented. The paper stands out also with its internal consistency and the capability to use the empirical data deriving from interviews in a very convincing way. Overall, the paper provides an excellent contribution to the field and it is likely to be used in future research on knowledge exchange.

Justyna Bandola-Gill works at the intersection of Science and Technology Studies and Public Policy. Her research explores the interactions between research and policy, especially the ways in which knowledge is organised, governed and mobilised across different settings in order to achieve political goals. Her recent publications, drawing on her doctoral research include a paper *Between relevance and excellence? Research impact agenda and the production of policy knowledge* published in *Science and Public Policy* and a co-authored book *Impact Agenda: Controversies, Consequences and Challenges* (Polity Press). Currently, Justyna is a Post-doctoral Researcher, working on an ERC-funded project exploring the global rise of a metrological fields (METRO: <http://www.metro-project.eu/>), where her research explores the production and governance of global poverty indicators by International Organisations. Call for Nominations: 2020 Excellent Paper Award from an Emerging Scholar

The fifth call is underway and we encourage all SG members to nominate their junior colleagues or themselves for this prize. Details are accessible on the Standing Group's website and the deadline for submission is 15th January 2021. **A nominee is eligible if she/he fulfills all of the following criteria:**

- Is currently enrolled in a PhD programme or has obtained PhD after August 2017;
- Is the sole or Lead Author in the paper, and the paper is topically relevant for the Standing Group;
- Presented the paper at a conference or workshop between November 2019 and November 2020
- Is a registered member of the Standing Group
- Submit the application to Martina Vukasovic (martina.vukasovic@uib.no) by **15 January 2021**.

Application should consist of:

- A paper presented (less than 8000 words, excluding references), along with details of the conference (panel title, date of presentation);
- CV (2 pages, including details of institutional affiliation);
- A short statement of support from PhD supervisor, or a committee member, or Panel Chair/Discussant.

What is the role of knowledge today when almost every aspect of our lives is affected by the global pandemic? What changes does this radically new situation bring to politics and policies of science, technology and higher education? These and other questions were discussed at the **Knowledge Politics and Policies** Section of the first virtual General Conference of the European Consortium for Political Research (ECPR) 24-28 August 2020. At this year's conference the ECPR not only celebrated its 50th anniversary but also addressed some of the most pressing topics of our times such as gendered impact of Covid-19 crisis and decolonisation of curriculum and political practice. The conference connected some 2200 researchers to discuss 1804 papers in 72 sections and 443 panels.

This is the official blog for ECPR Standing Group on Knowledge Politics and Policies. (Previously - ECPR Standing Group on the Politics of Higher Education, Research and Innovation). We started as UACES's collaborative research network on the European Research Area (2013-2016). This Standing Group brings together scholars whose work relates to the deeply interconnected fields of higher education, research, and innovation to encourage debates and research on the politics and policies in these areas. Over the past decades, several developments have contributed to the growing political significance of higher education, research, and innovation in international, regional, and national arenas. 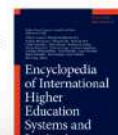
