



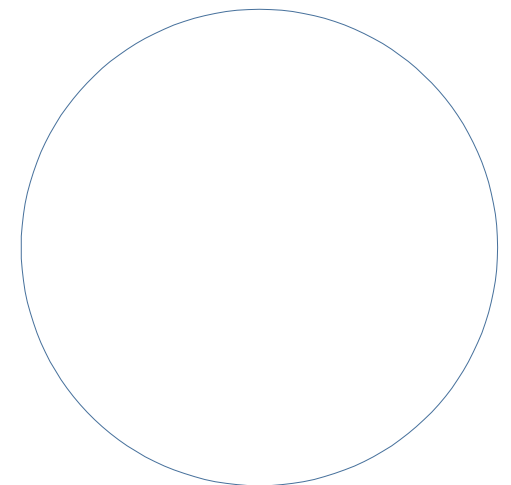

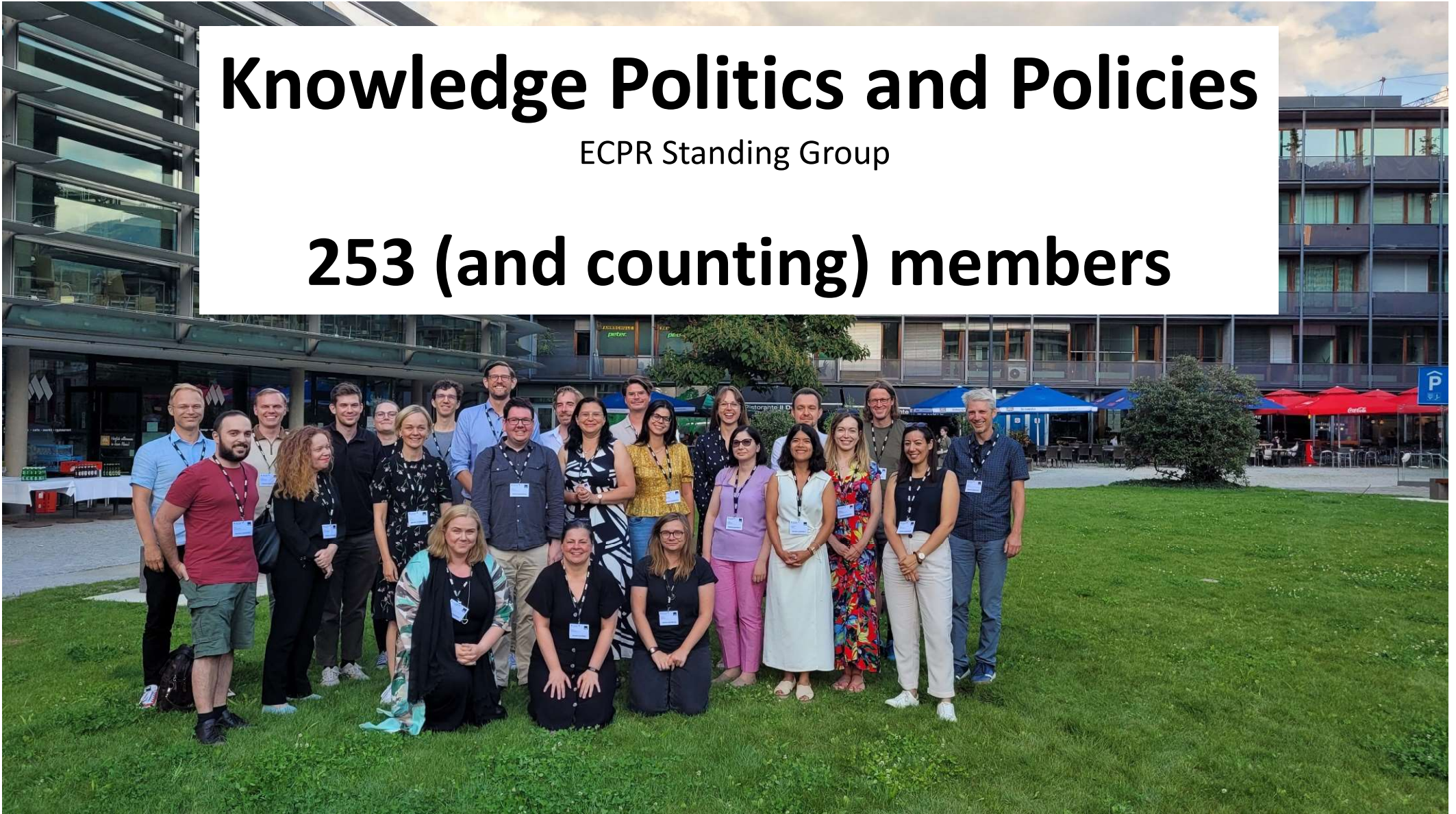

Excellent Paper Competition 2023

- Eligibility

- Is an «emerging scholar» = currently enrolled in a PhD programme or has obtained PhD after January 2019;
- Is the Sole or Lead Author in the paper + the paper is topically relevant;
 - Papers where all authors are emerging scholars are given priority;
- Presented the paper at a conference or workshop between November 2022 and November 2023
 - A revised version of the paper can be submitted for the competition (→ use the feedback received at the conference/workshop)
- Is a registered member of the Standing Group when applying
- Submits application to martina.vukasovic@uib.no by **1 February 2024**

- Application consists of:

- Paper presented (less than 8000 words, excluding references), along with details of the conference (panel title, date of presentation)
 - CV (2 pages, including details of institutional affiliation)
