CiteScore 2022: 2.1 CiteScore Rank: 463/1415 (Sociology & Political Science) Percentile: 67th (Sociology & Political Science)

IF 2yr 2021: n/a IF 2yr 2022: 0.8 IF 5yr 2022: 1.1

CiteScore calculation is based on Scopus data, while Impact Factor is based on Web of Science data. CiteScore uses a 3year window while Impact Factor adopts a 2-year window. CiteScore includes all document types indexed by Scopus, include articles, reviews, letters, notes, editorials, conference papers, etc.




