

# Q1 How long have you been a member of the ECPR Standing Group on Internet and Politics?





## Q2 Do you belong to any other Standing Group?











## Q6 Why did you not participate in any events?





#### Q7 How did you find out about the Standing Group?





#### Q8 What benefits do you receive through your SG membership?





# Q9 Content-wise, the SG encompasses 3 main aspects of Internet and Politics research. Which aspect(s) describe(s) your own field of expertise best?





# Q10 How do you find the SG's thematic scope: too wide, too specific or just fine?





## Q11 The Standing Group should be redefined. Do you agree?





#### Q12 What solution do you think should we approach for the future?




