- In total, panels are 1h45 minutes, making that there will be a total of 21 minutes per paper for panels with 5 papers, 26 minutes per paper for panels with 4 papers.
- To ensure sufficient time for feedback and discussion (especially for the panels with 5 papers), we advise authors
 to limit their presentation to 10 minutes. In panels with fewer papers, this can be adjusted as the chair /
 discussant(s) see fit.
- Discussants are advised to spend about 5 minutes for their discussion (per paper).
- Discussants can divide the papers amongst themselves to provide comments as they see fit.
- Papers can be either uploaded on the ECPR submission website or can be circulated via panel chairs & discussants via e-mail.

Best paper award

- Please note that there will be a "Best Paper Award" for the best paper that is being presented in the "Political Communication: Theoretical Challenges, Empirical Opportunities" section.
- As chair and discussant, we ask you to nominate 1 paper (in consensus) of the panel that will be eligible for the Best Paper Award. Please notify us if there is a conflict of interest. We would like to receive your nomination at the latest <u>September 2</u>.
- Only papers will be considered that have been shared within the panel in advance of the conference (deadlines are determined by the panel chair). Papers must not be published at the time of the conference.
- 1 Paper per panel will be nominated, resulting in a longlist of 8 papers, which will be evaluated in the fall 2022 by an external jury. Eligibility is regardless of career stage and of ECPR membership status. However, papers that are (co-)authored by members of the Steering Committee or by the Section Organizers are not eligible for the award.
- Evaluation criteria are: relevance & contribution to field, novelty / originality, soundness of method & academic rigor, clarity & structure, originality, language
- We are looking for jury members: please feel free to reach out to us if you would like to be part of this jury (which mean you would need to read and evaluate 2 papers). It builds on four pillars – quality, depth, accessibility, and exchange – thereby offering a dynamic platform to advance research, innovation and debate across the breadth of political science. It welcomes significant theoretical, methodological, and empirical contributions from all fields, including political communication. Call for Papers: special issue Multilingualism in Computational Communication Research

Dear colleagues,

We are inviting contributions for a special issue on 'applying & validating multilingual text analysis for social science research' in Computational Communication Research. The special issue will bring together papers that develop, validate, explain, and apply multilingual computational text analysis methods. We welcome two different types of submissions:

- Research Articles: manuscripts that introduce, use, and validate multilingual computational methods to examine
 important theoretical questions in communications, political science, or other social sciences. This also includes
 manuscripts that make a theoretical and fundamental methodological contribution to our understanding of
 multilingual CTAM.
- Workshop Articles: manuscripts that explain how to use an existing or novel computational method to study
 large multilingual datasets. Workshop manuscripts are expected to be very practical, to include open-source
 code that readers can adapt for their own work, and to have clear recommendations about which
 fields/questions can benefit from the described method.

Extended abstracts (limited to 1500 words) should be submitted through the journal's online <u>system</u> no later than 12 September, 2022. More detailed information and submission guidelines can be found on the CCR <u>website</u>. Deadlines

- Extended abstracts are due September 12th, 2022.
- Decisions on the extended abstracts will be made by September 19th, 2022.
- Full papers for accepted extended abstracts will be due November 30th, 2022. Papers will then be subject to external blind peer review.
- Publication of final accepted articles is expected in the first half of 2023.
