# WITNESS SEMINAR: 'THE COLD WAR CHALLENGE TO THE CHRISTIAN CHURCHES'

Thursday, 29 November, 2012, 1 pm - 4 pm.

Place: Room CM238, Aldgate Campus, London Metropolitan University, Goulston Street, London E1 7TP.

The Faculty of Law, Governance and International Relations, London Metropolitan University, the School of History, University of Ulster and the Institute of Contemporary British History (ICBH), Kings College London, are jointly organising a seminar on: The Cold War Challenge to the Christian Churchesq The event will be held in Room CM238, Aldgate Campus, Goulston Street, London Metropolitan University, London E1 7TP on Thursday 29 November 2012.

The seminar will bring together a panel of Christian activists involved in different capacities with the problems of the churches and East-West relations going back to the 1960s. In particular, the panelists possess critical insights into two significant institutional responses to the Cold War challenge to the Christian Church, the British Council of ChurchesqEast-West Relations Advisory Committee and the Centre for the Study of Religion and Communism (later Keston Institute).

The seminar will take the form of an interactive group interview, introduced by Professor Jeff Haynes and chaired by Dr Dianne Kirby, the UK co-ordinator of the research project £hristian World Community and the Cold Warq for which the seminar is the first event to be held in Britain. It is intended that the oral history interviews and historical analysis will help us to better understand the extent to which the Cold War was a religio-political enterprise that confronted the churches with profound challenges on a number of levels that are now attracting serious attention from Cold War scholars.

### CALL FOR CONTRIBUTORS

### Essays in Anarchism and Religion

A book to be edited by <u>Alexandre Christoyannopoulos</u> and <u>Matthew Adams</u> and submitted to an *open access* academic publisher.

Anarchism and religion have long had an uneasy relationship. On the one hand, many anarchists insist that religion is fundamentally incompatible with anarchism, recalling that anarchism calls for £10 gods, no mastersq pointing to the many cases of collaboration between religious and political elites in oppressing and deluding the masses, arguing that religious belief is superstitious, and so on. On the other hand, some religious/spiritual anarchists insist that their religious/spiritual tradition cannot but lead to a rejection of the state, care for the downtrodden, and quest for a more just society. despite, indeed sometimes because of, the acceptance of a god as £10 anarchists.

A number of recent publications both in religious and anarchist studies have focused on religious anarchism, but consideration of their compatibility in the first place has been rarer. The aim of this edited book is to explore critically and frankly the relationship and tensions between these two notions. The collection will build on the successful stream exploring the topic convened for the <a href="Anarchist Studies Network">Anarchist Studies Network</a> Conference held at Loughborough University in September 2012. Authors of papers presented at the stream are invited to submit their manuscripts, but the call is also open to authors who did not attend the conference, yet wish to submit a manuscript for consideration.

Proposals are encouraged from sceptical as well as sympathetic perspectives, the aim being to foster critical discussion. In line with the panel themes at the conference, areas of focus could include: anarchist encounters with religion, anarchist Biblical studies, anarchist theology, anarchism/religion parallels, religious and anarchist philosophers/philosophy, and spiritual anarchism.

Questions that may be addressed include (but are not necessarily restricted to):

- Is rejection of religion (and/or spirituality) a sine qua non of anarchism?
- What do we mean by ±eligionq ±spiritualityqand ±narchismqwhen considering their relation?
- What is unacceptable to anarchism about religion/spirituality, and to religion/spirituality about anarchism?
- Are some religious/spiritual traditions inherently more compatible with anarchism than others?
- Why do religious institutions tend to move away from the often radical intentions of their original prophets and founders? How does this compare to non-religious institutions?
- What explains differences in the reception of religious/spiritual anarchism across different contexts?
- To what extent can religious/spiritual anarchistsqdeification of religious/spiritual notions (such as £od) be compared to non-religious anarchistsqdeification of secular notions (such as freedom or equality)?
- What role do (and can) religious/spiritual anarchists play in the wider anarchist movement, and in their wider religious/spiritual tradition?
- What can religion/spirituality and anarchism learn from one anothers history and ideas?
- Is religious/spiritual anarchism really anarchist? Is it really religious/spiritual?

#### **Abstract**

By looking at the case of Lithuanian yeshivas in Israel, Yohai Hakako book explores the internal tensions and dynamics of religious orders during a stage of a relative loss of charisma, in which the enthusiasm of the founding generation has diminished. It is the first study to include participant observations conducted within these institutions, which are the sacred heart of this segregated and highly religious community. The book highlights the current crisis these fundamentalist institutions are going through marked by a dramatic growth in yeshiva dropout rates. It examines the new and innovative ways the rabbis are trying to respond to the crisis. As part of these attempts the rabbinical discourse portrays a unique utopian and egalitarian world governed by supernatural forces and unlimited spiritual resources and incorporates Western psychological and democratic ideas.
