The meeting was chaired by the SG Convenor (SV).

MINUTES

1. Votes of Thanks

The meeting began by expressing appreciation:

- to Routledge for generously sponsoring the wine reception. The Group also appreciated the presence of two Routledge representatives, Joe Couchman and Ruth Miller, at the meeting.
- to Martin Mejstrik for acting as local organiser for the Group at the Prague conference and in particular for arranging the business meeting and reception
- to Georgios Karyotis for his work as co-convenor (with SV) of the SG's Section on *Reconfiguring Southern Europe* at the Prague General Conference.

2. Outgoing Convenor's Report

The outgoing Convenor presented a report on the SG's activities during the period since her re-election in September 2013 until the handover to the new Steering Committee in September 2016. Main points concerned:

- presentation of the **academic events** organised by the SG both within ECPR (three Sections at the ECPR General Conferences in 2014, 2015 and 2016; a Workshop at the 2015 Joint Sessions; a Research Session at the 2016 Research Sessions) and outside ECPR (2 panels at the 2014 PSA conference, 2 panels at the 2015 UACES conference, 2 panels at the 2016 UACES conference)
- actions in support of academic freedom (participation in appeal to ECPR Executive Committee to take a public stand on the Regeni murder, February 2016;
 SG 'Statement on Academic Freedom in Turkey' following the attempted coup of July 2016)
- active presence within ECPR in the response by the SG Convenors to the deliberations on the new 'Framework on Standing Groups and Research Networks', 2014-15
- the very **satisfactory growth in membership** from 97 members in September 2013 to 329 members today, making the SG on SEP the 6th largest of the 52 current SGs. Contrary to expectations, membership numbers rose significantly following the new system of electronic registration through the ECPR web page in 2015 but were badly affected by the first process of annual renewal at the end of the year. Membership numbers rose significantly during the Steering Committee election but this will not be repeated next year. The Convenor had raised the issue with the ECPR Executive Committee representatives during the Standing Group Convenors' meeting on 9 September, suggesting renewal every 2 or 3 years. All members were urged to renew their membership at the end of 2016.
- the **democratic vibrancy** within the SG demonstrated by the first electronic election (19 April-19 May 2016) with 6 candidates for 3 positions and a 47% turnout which compared well to the experience of other ECPR SGs.
- **intra-group communication** with the website (introduced in 2014) and the Facebook page (2016) alongside the established system of information emails.

3. SG Facebook Group

Isabel David reported on the creation of the SG's 'Southern European Politics' Facebook group. A closed Group was chosen to avoid spam posts. The Group has been very successful. Founded in June 2016, just three months later it already has 309 members, nearly as many members as the SG itself. The membership is not entirely overlapping which means the FB group has attracted attention beyond the SG itself. Isabel encouraged those members of the Group who have not yet done so to join the FB group. Those who have only signed up to FB should also join the SG. Members are already posting regularly on the site and Isabel encouraged members to post their new publications, calls for papers, information on their new research projects etc. The Convenor thanked Isabel for her important initiative in launching the FB Group and both Isabel David and Myrto Tsakatika for acting as its administrators.

4. Introduction of the new Steering Committee

The members of the new Steering Committee thanked the members for voting for them.

- SV announced she will be continuing as the incoming SG Convenor.
- Marco Maraffi (University of Milan, incoming Co-convenor) announced that he is the incoming Co-convenor and looks forward to working with the Group over the next three years.

• Myrto Tsakatika (University of Glasgow, incoming Treasurer) mentioned that she and her colleagues at the University of Glasgow are looking forward to contributing to the development of South European Studies in the North of Europe with Glasgow developing a role as a hub. She suggested that the SG leadership should play an enabling role, co-ordinating and supporting the aims and activities of the members. She invited members to be active in contributing ideas and initiatives in order to ensure we have a vibrant SG.

5. Planning of future Standing Group activities

- *General Conference:* Ideas were discussed for the SG's proposal for a Section at the next General Conference in Oslo, September 2017.
- *Joint Sessions*: The meeting was informed of the announcement at the Standing Group Convenors' meeting that proposals for Workshops have additional chances of success if sponsored by a Standing Group. The Convenor will send out a reminder when there is a call for workshops.
- Extra-ECPR activities: It was agreed the SG should continue to organise dedicated panels at conferences outside the ECPR framework and members were encouraged to think of opportunities to do this. Interest was expressed in the organisation of SG panels at the conferences of the national political science associations in Southern Europe.
