SG Citizenship wishes to make such section proposals that are based on the research done by its members and therefore seeks to encourage inclusive participation of the members at all phases. This is why the stages of proposing a section are as follows:

- i. The SG Citizenship committee drafts a call for panels and sets an internal deadline that is sent to our members and advertised on our website.
- ii. Based on the panel proposals received by the deadline, the committee finalises the section proposal with a tentative list of panels to be submitted through the ECPR website.
- iii. When the Academic Convenors of the ECPR have confirmed the section accepted, a call for panels and papers is opened. All the tentative panels included in the section proposal must now be proposed by the panel chairs through the ECPR website. Based on the amount of proposals, SGs are allocated a certain number of panels, which means that every proposal is important.
- iv. Based on the paper and panel proposals directed at the section, section chairs finalise the sections.
- v. If too many panels are proposed for the SG Citizenship Section, there is the option to transfer panels to another section (organised by a different SG). In any such cases the consent of panel chairs/organisers will be gathered.
- vi. SG Citizenship members are invited to form new, smaller sections. These sections can be proposed via the ECPR website directly (for further information, please visit: http://ecpr.eu/Events/EventDetails.aspx?EventID=96)
- b. Joint sessions 2019 in Mons
 - i. Call for Workshops 1 Oct 2017-1 Feb 2018
- c. Summer schools and other ECPR activities
- d. SG Citizenship workshops, etc...
 - i. Smaller research sessions on citizenship, entirely organised by SG members, supported by the SG Citizenship committee and the main ECPR admin centre. Possibly a joint publication project as an output?
