The mentoring session is organized by the Standing Group on Political Parties. We welcome contributions on Political Parties and Participation and Mobilization, Political Networks, Political Violence, Interest Groups, and Environmental Politics and other subjects with a link to the study of Political Parties. This event will take place on 'day zero' (August 22) of the next ECPR General Conference in Hamburg from 3 to 5 pm. Note that the event does not overlap with the official conference program, as 'day zero' is exclusively reserved for registration. **If you choose to attend, please make sure you arrive in Hamburg on time.** We hope that after already two successful first editions over the last two years, we will have another productive session this year.

In case you do, we ask you to restrict the proposal to no more than two pages and we invite you to send your proposals to Felix-Christopher von Nostitz, also no

later than July 31. Please also indicate the duration of research project/post-doc proposal and the name of funding body to which you aim to submit the proposal. This allows the experts to provide more detailed feedback on your proposal. Due to limited time we cannot guarantee that all proposal will be accepted for discussion, but all applicants are accepted to participate in the overall event. If your proposal is accepted for discussion please prepare a short (2-3 min) presentation of your proposal for the rest of the group.

**About the presenters:**

**Nicole Bolleyer** is Professor of Comparative Politics at the University of Exeter. She holds a PhD from the European University Institute in Florence (Italy). Nicole's research interests include institutional and organizational theory, party politics, the study of voluntary organizations, comparative federalism and multilevel governance as well as theories of legitimacy. Currently, Nicole directs a five-year research project on Regulating Civil Society: A Comparative Study of Parties, Interest Groups and Welfare-Providing Organisations funded by the European Research Council, which underpins her third monograph 'The State and Civil Society: Regulating Interest Groups, Parties and Public-Benefit Organisations in Contemporary Democracies' (forthcoming with Oxford University Press)

**Emilie van Haute** is Associate Professor at the Cevipol (ULB). Her research interests focus on party membership, intra-party dynamics, factionalism, elections and voting behaviour. Her current research projects include the MAPP working group ([www.projectmapp.eu](http://www.projectmapp.eu)), Partirep ([www.partirep.eu](http://www.partirep.eu)), and PPDB projects ([www.politicalpartydb.com](http://www.politicalpartydb.com)). She is co-editor of Acta Politica and of the ECPR-Oxford University Press Comparative Politics Book Series. She published extensively on her various research interests for example she was co-editor of the recent book Party Members and Activists (Routledge, 2015).
